# **Registered Practitioner**

To qualify as a CRA Registered Practitioner, the applicant will have studied and completed an 8 hour minimum of Level I (1st degree) Reiki class and will have completed the required case studies. They will complete the application form, sign and agree to abide by the CRA Code of Ethics, Disciplinary Action Policy, Code of Conduct & Scope of Practice forms.

# Registered Teacher

To qualify as a CRA Registered Teacher, the applicant will have studied and have successfully completed the minimum teaching requirements for the style of Reiki they studied. This may consist of three or four levels of training depending on their Lineage. It will not be less than three levels consisting of a minimum of twenty eight hours of training in total. The applicant will submit all required documents which includes a signed Code of Ethics, Disciplinary Action, Code of Conduct, Scope of Practice, Educational Guidelines, and Class Outlines.

The Canadian Reiki Association upholds the membership to a strict Code of Ethics, Code of Conduct, Disciplinary Action Policy and Educational Guidelines, to ensure that all Registered Teachers and Registered Practitioners adhere to excellence and ethical practice. As a Registered Teacher you will agree to abide by and continually support your students. We encourage our teachers to host one student practice night per month for the purpose of issuing C.E.U.'s to student members.

All Registered Teacher applicants must submit copies of their class outlines in theory and practical for review and approval by the Board of Directors. Class outlines and all required signed documents may be submitted by email in PDF to:

reiki@reiki.ca or mailed to the C.R.A.

*C.R.A. Registered Teachers* visibly display their CRA Designation and Registration number on every certificate they issue to their students.

#### Example:

CRA-RT 01-054 will be displayed with their name.

# Supportive Member

A Supportive Member is someone who may not be attuned to Reiki or the member may be attuned to Reiki and not practicing at this time. They do support the efforts of the C.R.A. and wish to be a part of the movement. Supportive Members will have no voting rights nor will they hold a position on the Board.

# **Student Member**

To qualify for this level of membership, the applicant must be attuned to Reiki and have taken a minimum of Level I (1st degree class and submit a copy of their Reiki certificate, signed copies of the CRA Code of Ethics, the CRA Disciplinary Action Policy, Scope of Practice & Code of Conduct This level of membership has no voting rights.

#### Please Note

CRA Student Members may upgrade their membership to Registered Practitioner upon the six month anniversary of receiving Level 1 certification and meeting the current criteria. They must complete 24 required case studies (on CRA forms), or a combination of case studies and CEU forms, totaling twenty four hours of practice time . This is mandatory. CEU forms may be obtained when attending a CRA Reiki Exchange or at a Reiki Practice Night hosted by a CRA Registered Teacher. Upon completion of the six month waiting period and completion of twenty four hours of practice, the Student Member is eligible to apply for Registered Practitioner level.
