Case Study Report Form
(To be used for multiple sessions for Animals)

CRA definition of Case Study: a case study is a single report of the experience and outcome of a Reiki session on the same animal. This allows the Animal Reiki Practitioner an opportunity to practice the theory and practical elements of Reiki, with a willing participant in order to meet the required criteria for application as a CRA Registered Animal Reiki Practitioner.

You must do case studies with at least 3 different animal. The three different animals can be owned or under the care of the same client. You may not accumulate all of your hours doing sessions with the same animal client. Personal pets are excluded from the case studies

One sixty (60) minute Reiki Session equals one case study. Sessions reported may not be less than 60 minutes. They must add up to 60 min. to equal one case study. i.e. Three 20 minute, Four 15 minute, OR six 10 minute sessions equals one case study. Sessions longer than 60 minutes will equal one case study.
